Rules & Regulations

1. All dogs must have current vaccinations for: Canine Distemper, Canine Parvovirus, and Rabies. Titre tests are accepted. Bordetella (Kennel Cough) vaccine is highly recommended but not mandatory, please discuss with your vet as to if your dog should have this vaccination. Proof of mandatory vaccinations are required before your pet's participation in services at Sprockett's Doggy Day Camp Inc.
2. All dogs must be deemed sociable, friendly, and appropriate candidates for daycare and boarding before using Sprockett's Doggy Day Camp Inc. services. Sprockett's Doggy Day Camp Inc. will not accept aggressive pets under any circumstances. Sprockett's Doggy Day Camp Inc. reserves the right to decline any new pets for any reason.
3. Sprockett's Doggy Day Camp Inc. reserves the right to no longer accept any pet for any reason, i.e: aggressive behavior, constant fighting, etc. The owner will be notified and remaining pre-paid days will be refunded.
4. Sprockett's Doggy Day Camp Inc. reserves the right to manage bad behavior in your pet(s) by placing them on a leash for safety, on a leash post or in a kennel for a short time-out. You will be notified if this was required. At times a muzzle may be required for the safety of all dogs; this will be discussed with you prior to implementing this training tool.
5. All fees must be paid in full at time of pick-up. Passes must be paid in full before usage.
6. Emergency contact information must be given and kept in our records.
7. Sprockett's Doggy Day Camp Inc. *will not* provide food for pets. Owners are required to provide any food or treats their dog(s) will need while in our care. Sprockett's Doggy Day Camp Inc. staff will gladly ensure that it is given on time and notify you of any uneaten meals
8. All dogs must be spayed or neutered to be eligible to participate in daycare. Puppies that are attending must be spayed or neutered by the age of 8 months in order to continue to use Sprockett's Doggy Day Camp Inc.
9. Only Sprockett's Doggy Day Camp Inc. staff is permitted in the play areas.
10. Dog owners must inform Sprockett's Doggy Day Camp Inc. of any illnesses that their pet(s) may have contracted and are asked not to bring them back until healthy.
11. All dogs MUST be "under control" when entering and leaving Sprockett's Doggy Day Camp Inc. Owners are responsible for cleaning up after their pets while on the daycare's property. Any pet waste can be handed to one of our staff to dispose of.
